Our SOCaaS 360 services caters for advanced endpoint protection (AEP), endpoint detection and response (EDR), managed detection and response (MDR) which combines AEP, EDR and a network intrusion detection sensor, as well as the option to consume additional event sources such as firewalls, Microsoft AD and more. Key in this regard is a variety of service options that address our customer needs and budget concerns, including 24 x 7 x 365 monitoring, real-time analysis, incident management, incident response, as well as situational awareness via actionable threat intelligence dashboards and reporting.
